Dreams in Greek Tragedy

This book is the first that describes the practices of any stock exchange; it makes evident a high development of practices, with puts, calls, pools, and manipulations; and it appeared as early as the seventeenth century. Not inappropriately the stock exchange described is that of Amsterdam, a city which at the date of the volume's publication —1688 — was still the leading financial center of the world. The book, to be sure, is hardly a systematic account of the institution; the author pursued moral, philosophical, and rhetorical objectives, and, while saying a lot that seems now to be of little value, manages somehow to leave unsaid a great deal that would be of interest for us. Nevertheless, it represents, even in its peculiar form, a really important source of information about the stock exchange, and indeed about the Dutch business world of that period.

THE Department of Classical Philology of Columbia University has approved this monograph as a contribution to knowledge worthy of publication. We are happy to agree, and we hope that Mr. Messer will be able to fulfill his promise of further contributions to his chosen subject. He was led to the study of the dreams in Greek literature by the discovery -- which every serious student of Latin literature will make -- that without Greek you cannot get far into Latin; for he first set out to investigate Roman dreams (see "Mnemosyne," 45, 78-92). His present work is really introductory to a more general study of the ancient dream, especially as portrayed in Latin literature. It deals particularly with the dreams in Homer, Hesiod, and the Tragedians, (I) as a part of the machinery, a motive force in the development of action, narrative, plot, and (2) as artistic ends in themselves, more or less complete, more or less refined, more or less natural or artificial. The author has collected, for his own purposes, all dreams and references to dreams that he can find in Greek or Latin literature down to the second century A.D., and his footnotes give proof of his wide reading and of the intrinsic interest of his materials. His style is somewhat inelegant, and his arrangement unattractive. His method is to plough solemnly through the

whole field, noting and discussing each dream as it appears. Accordingly there is too much repetition, and a bewildering abundance of cross-references. If only he had added a short chapter summarizing his results, his work would have been more likely to be recognised for what it is -- a very sound and useful piece of not particularly inspired research. That the author is no mere compiler is shown by many touches of just literary appreciation. He is at his best in pointing out that Penelope's dream of geese and eagle (Odyssey XIX.) is unlike other dreams in Homer, an allegorical vision which demands interpretation, "a new departure for the epic, and a model for the allegorical dreams of tragedy.' The second part, in which the eagle returns and announces him as Odysseus, is in the manner of the older type, the objective dream which tells its own tale without any mystery; and this addition, Mr. Messer thinks, is an indication that the poet felt uneasy about the introduction of the new technique (pp. 33-4). Excellent, again, is the remark (p. 57) that 'the immediate source of the dream in tragedy is to be found not in religion and cult, but in the literature.' So is the discussion (p. 81 ff.) of the dream in Sophocles' "Electra," where the old literary motif is adapted, not so much for its mechanical effect upon the plot as for its value as a means and an excuse for the portrayal of character. Finally, the description of the dream in Euripides' "Iphigenia in Tauris" as approximating to 'the highly chiseled miniatures in which the Alexandrian period delights, 'strikes me as just and illuminating. Where Mr. Messer sticks to the literature and his own commonsense, his work is sound and useful. Myth and Literature

From the Introduction, by Caroline Walker Bynum: The opportunity to rethink and republish several of my early articles in combination with a new essay on the thirteenth century has led me to consider the continuity-both of argument and of approach-that underlies them. In one sense, their interrelationship is obvious. The first two address a question that was more in the forefront of scholarship a dozen years ago than it is today: the question of differences among religious orders. These two essays set out a method of reading texts for imagery and borrowings as well as for spiritual teaching in order to determine whether individuals who live in different institutional settings hold differing assumptions about the significance of their lives. The essays apply the method to the broader question of differences between regular canons and monks and the narrower question of differences between one kind of monk--the Cistercians--and other religious groups, monastic and nonmonastic, of the twelfth century. The third essay draws on some of the themes of the first two, particularly the discussion of canonical and Cistercian conceptions of the individual brother as example, to suggest an interpretation of twelfth-century religious life as concerned with the nature of groups as well as with affective expression. The fourth essay, again on Cistercian monks, elaborates themes of the first three. Its subsidiary goals

are to provide further evidence on distinctively Cistercian attitudes and to elaborate the Cistercian ambivalence about vocation that I delineate in the essay on conceptions of community. It also raises questions that have now become popular in nonacademic as well as academic circles: what significance should we give to the increase of feminine imagery in twelfth-century religious writing by males? Can we learn anything about distinctively male or female spiritualities from this feminization of language? The fifth essay differs from the others in turning to the thirteenth century rather than the twelfth, to women rather than men, to detailed analysis of many themes in a few thinkers rather than one theme in many writers; it is nonetheless based on the conclusions of the earlier studies. The sense of monastic vocation and of the priesthood, of the authority of God and self, and of the significance of gender that I find in the three great mystics of late thirteenth-century Helfta can be understood only against the background of the growing twelfth- and thirteenth-century concern for evangelism and for an approachable God, which are the basic themes of the first four essays. Such connections between the essays will be clear to anyone who reads them. There are, however, deeper methodological and interpretive continuities among them that I wish to underline here. For these studies constitute a plea for an approach to medieval spirituality that is not now--and perhaps has never been--dominant in medieval scholarship. They also provide an interpretation of the religious life of the high Middle Ages that runs against the grain of recent emphases on the emergence of "lay spirituality." I therefore propose to give, as introduction, both a discussion of recent approaches to medieval piety and a short sketch of the religious history of the twelfth and thirteenth centuries, emphasizing those themes that are the context for my specific investigations. I do not want to be misunderstood. In providing here a discussion of approaches to and trends in medieval religion I am not claiming that the studies that follow constitute a general history nor that my method should replace that of social, institutional, and intellectual historians. A handful of Cistercians does not typify the twelfth century, nor three nuns the thirteenth. Religious imagery, on which I concentrate, does not tell us how people lived. But because these essays approach texts in a way others have not done, focus on imagery others have not found important, and insist, as others have not insisted, on comparing groups to other groups (e.g., comparing what is peculiarly male to what is female as well as vice versa), I want to call attention to my approach to and my interpretation of the high Middle Ages in the hope of encouraging others to ask similar questions.

Tombstones provide the largest single category of epigraphical evidence from the worlds of ancient Greece and Rome, and their inscriptions have been widely studied with reference to art and cultural

history, ancient social history, prosopography and onomastics. But even though students of history and archaeology devote extensive attention to death and burial in antiquity, epigraphy - the study of inscriptions - remains, for many, an abstruse subject.

Roman Rule and Civic Life

Essays in Modern Jewish History

In the first comprehensive study of election law since the Supreme Court decided Bush v. Gore, Richard L. Hasen rethinks the Court's role in regulating elections. Drawing on the case files of the Warren, Burger, and Rehnquist courts, Hasen roots the Court's intervention in political process cases to the landmark 1962 case, Baker v. Carr. The case opened the courts to a variety of election law disputes, to the point that the courts now control and direct major aspects of the American electoral process. The Supreme Court does have a crucial role to play in protecting a socially constructed "core" of political equality principles, contends Hasen, but it should leave contested questions of political equality to the political process itself. Under this standard, many of the Court's most important election law cases from Baker to Bush have been wrongly decided.

Translation and Identity

What unites and what divides Americans as a nation? Who are we, and can we strike a balance between an emphasis on our divergent ethnic origins and what we have in common? Opening with a survey of American literature through the vantage point of ethnicity, Werner Sollors examines our evolving understanding of ourselves as an Anglo-American nation to a multicultural one and the key role writing has played in that process. Challenges of Diversity contains stories of American myths of arrival (pilgrims at Plymouth Rock, slave ships at Jamestown, steerage passengers at Ellis Island), the powerful rhetoric of egalitarian promise in the Declaration of Independence and the heterogeneous ends to which it has been put, and the recurring tropes of multiculturalism over time (e pluribus unum, melting pot, cultural pluralism). Sollors suggests that although the transformation of this settler country into a polyethnic and self-consciously multicultural nation may appear as a story of great progress toward the fulfillment of egalitarian ideals, deepening economic inequality actually exacerbates the divisions among Americans today.
