It is much more affordable for law firms to employ ample paralegals to help attorneys fulfill research duties and other responsibilities than it is to employ more lawyers. Paralegal can "handle broad range of administrative and research duties under the supervision of attorneys. For example, during the course of a day, they may organize and maintain legal files or draft documents, deliver or retrieve documents from the courthouse and conduct intensive legal research. Paralegals also investigate the background facts of cases, organize evidence and documents for attorneys to review, accompany lawyers to court, and manage schedules with witnesses and experts" ("How To Become, n.d.). As per the responsibilities of a paralegal, "specific responsibilities can vary greatly, depending on the department, office or law firm in which a paralegal works" ("How To Become). Law firms constantly delegate work to paralegals and have become less dependant on hiring more lawyers to fulfill research duties. In stark contrast to lawyers, a paralegal who has earned a paralegal certification is not required to take continuing education courses in perpetuity to continue to work.
